This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in enforcement action. Additional information is needed for the following $\underline{2}$ item(s):

1. Line 10 of the Summary Page of your report discloses a total of \$2,000 in debts and obligations owed by the committee. The sum of the entries itemized on Schedule C, however, indicates the total to be \$4,000. Please amend your report to clarify the discrepancy. (11 CFR § 104.3(a) and (b))

2. Please provide Schedule C to support the amount of \$2,000 reported on Line 9 of the Summary Page. Loans must be continuously reported until they are either repaid or settled. (11 CFR §104.3(d) and 52 U.S.C. §30104(b)(8) (formerly 2 U.S.C. §434(b)(8)))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just
