This is in response to your letter regarding the Report referenced above. It appears that our auditor neglected to indicate on Reports submitted to the FEC whether the contributions were for primary or general elections. During a telephone conversation my secretary, Phebe Davis, had with Donald Averett of your office on May 25, Mr. Averett indicated that this would have an impact on determining the allocation of all contributions.

I have contacted Alan Wheat, the candidate for whom contributions were in question. Your correspondence to this office was faxed to Mr. Wheat, and he has assured me that he will personally take steps to resolve this issue. Also, I have sent a letter to the Friends of Alan Wheat Committee (copy enclosed), requesting that they research their records and inform this office of all contributions they have received from our PAC and how they were allocated. Additionally, a request was made for a \$500 refund, if excessive contributions were made.

I hope that this adequately addresses the issue in question. An amended return will be filed as soon as we receive a response from the Friends of Alan Wheat Committee.
