Please be advised that a Leadership PAC is defined as "a political committee that is directly or indirectly established, financed, maintained or controlled by a candidate for Federal office or an individual holding Federal Office but which is not authorized committee of the candidate or individual and which is not affiliated with an authorized committee of the candidate or individual except that leadership PAC does not include a political committee of a political party." 11 CFR §100.5(e) (6)

Please amend your filing by placing the name of the candidate for Federal office or an individual holding Federal Office on Line 6, or by providing clarification of your committee type.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee

will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
