In response to your letter dated May 23, 2002, we have electronically filed an amendment to our Amended June Monthly Report (5/1/01 - 5/31/01) to:

- Clarify the original check pertaining to \$1,250.00 we received from Wells Fargo & Company reimbursing us for a forged check claim. This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:


-It appears that the refund on Schedule A supporting Line 15 (pertinent portion attached) from Wells Fargo & Company for the forged check claim has not been disclosed on a disbursement Schedule B. Please amend your filing to disclose the original date that the check was disbursed, or provide clarifying information.

-Schedule B supporting Line 23 of your report discloses a contribution to Ben Cardin for Congress. However, you have indicated in the purpose of disbursement field "McCollum for Congress". Please clarify the ultimate recipient of this contribution and amend your filing.

Any amendment or clarification should be filed with the Federal Election Commission. Electronic filers must file amendments (to include statements, designations, and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
