
On September 6, 2006 Halliburton Company's Political Action Committee received a letter from you in regards to several errors found between our June and July monthly compliance reports. In reviewing our records, we determined that the \$1,500 difference between June's ending balance and the starting balance of July's amended report was caused by a change we had made to a June disbursement subsequent to June's filing.

Our original June 2006 report listed a disbursement in the amount of \$1,000.00 made to the David Wallace Campaign (Wallace for Congress) on May 30, 2006. This record was entered incorrectly, and was later amended to read \$2,500.00. We filed our original July 2006 compliance report before catching this mistake, necessitating an amendment for July. What we had neglected to do was to file an amendment for June as well, which would have accounted for the discrepancy between the two months.

On Thursday, September 14 Halliburton Company's Political Action Committee filed an amended June 2006 compliance report to rectify these errors. July's amended report should now be correct in light of the changes.

Please contact me if there is anything more that we need to do to resolve this situation, or if you notice additional discrepancies. We apologize for our errors, and appreciate your patience in allowing us the time to make the necessary adjustments.
