Dear Mr. Dobi:

This statement is in response to the Commission's letter dated May 13, 2021 regarding eight (8) items.

First, the Commission's letter requests clarification on two (2) contributions identified as possible corporations or labor organizations. Both of these contributions were refunded to the contributors.

Second, the Commission's letter requests clarification regarding sixty-two (62) contributors disclosed on the Original Report that appear to exceed federal contribution limits. As described below, all of those contributions were refunded to the contributors, returned to a joint fundraising committee ('JFC') in which the Committee participates for proper reallocation, or clarified as will be reflected on subsequent reports. Thirty-three (33) contributors had their excessive contributions refunded. Twenty-seven (27) of the contributors had their excessive contributions returned to the joint fundraising committee (Perdue Victory, Inc.- C00571620, Team Perdue - C00578542, or Senate Georgia Battleground Fund - C00736967) from which they came, to be reallocated to other JFC participants. The Commission identified one (1) apparent excessive contribution from a committee. This contribution was returned to a JFC in which our Committees. These excessive contributions were returned to a JFC in which our Committee participates.

Third, the Commission's letter requests clarification on contributions from one (1) committee not refunded within sixty days due to the tremendous volume of contributions received by our Committee. This contribution has been refunded.

Fourth, the Commission's letter requests clarification on contributions from eight (8) LLCs (limited liability companies). Six (6) contributions were refunded to the contributors. The Committee has confirmed that two (2) contributors used federally permissible funds for their contributions.

Fifth, the Commission's letter requests clarification on four (4) contributions identified as Non-Federal Committees. One (1) contribution was refunded to the contributor. The committee has confirmed that the three (3) remaining contributors used federally permissible funds for their contributions.

Regarding Items Six through Eight, the Commission's letter requests clarification on contributions identified as missing from 48 Hour Notices, appearing on duplicate 48 Hour Notices, and contributions that appear on 48 Hour Notices that did not appear on Schedule A. 48 Hour contributions that were identified as missing have already been corrected or added to Amended reports. 48 Hour contributions identified as duplicates have already been or will be corrected on Amended reports. The contributions that appeared on 48 Hour Notices but not on Schedule A were reported within 48 hours upon receipt by a JFC in which our Committee participates out of an abundance of caution and in the spirit of transparency and over-disclosing. These contributions were distributed to the Committee outside of the 48 Hour reporting period or not distributed at all.
