Dear Sir or Madam:

This letter is written on behalf of the Plasterers' and Cement Masons' Political Action Committee ("Committee") in response to your letter dated February 13, 1997 requesting some additional information regarding two entries made on the 30 Day Post General Report filed by the Committee. I previously wrote to you by letter dated February 6, 1997 and informed you that the two entries were erroneously reported as transfers from two unregistered political action committees. They should have been reported as unitemized contributions from members, collected by the local union collecting agents and temporarily held in the local union accounts.

In your recent letter you asked us to confirm that the contributions received from these unregistered organizations were forwarded within the appropriate time period. The Committee had determined and, after receiving your letter, has re-confirmed that the monies forwarded by these collecting agents were from member contributions received within 30 days of transmittal to the Committee and that no one individual contributed more than \$50.

It is our understanding that an amended report has been prepared and has been or is in the process of being filed with the Commission. Please contact me if you need any additional information or documentation regarding the source and timing of the above contributions received by the Committee.
