The Committee disclosed payments for Salaries/Wages for this period on Schedule H4 for Line 21a and Schedule B for Line 30b. The Committee paid its employees with 100% federal funds and disclosed the expenditures on Line 30b when the individual spent more than 25% of their compensated time in a given month on Federal Election Activity or activities in connection with a Federal Election. Those individuals who spent 25% or less of their compensated time in a given month on FEA or activities in connection with a Federal Election were paid with Federal funds and allocated on Schedule H4. In either case, all amounts spent for employee specific 'fringe benefits,' consisting of health insurance, disability insurance, life insurance, retirement benefits and payroll taxes were paid for and reported on a proportional basis equal to the amount associated with the individual that received the compensation and the funds with which the individual was paid. Any reimbursements/allocation transfers to the Committee's federal account from the Committee's non-federal account for salaries and/or benefits were associated with individuals whose activities do not exceed 25% in a given month. Receipts reported on Schedule A for Line 17, unless otherwise noted, were for the purchase of access to the Committee's voter file. The Committee believed this price properly reflected the fair market value of the file, which represented the normal charge for such data in our state. All costs associated with the voter file were paid 100% out of the federal account and were therefore not allocable. Payments listed on Schedule H4 for office supplies were payments either to vendors or reimbursements to individuals for basic supplies used for day-day operations. These items included, but were not limited to pens, paper, paper clips, pencils, ink, toner, video tapes, CDs, cups, toilet paper, paper towels, tissues, trash bags, coffee, tape, extension cords, light bulbs, labels, folders, organizers, envelopes, soap, cleaning products, etc...
