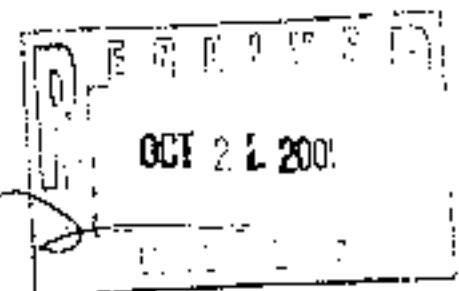
-Your calculations for Line 11(a)(iii), Columns A and B appear to be incorrect. Please provide the corrected total(s) on the Detailed Summary Page.
