This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following 2 item(s):

Your filings disclose that your committee may have satisfied the criteria for becoming a multicandidate committee; however, the Commission has no record of a FORM 1M (Notification of Multicandidate Status) filed by your committee. Please be advised that once a political committee meets the certification requirements of 11 CFR § 100.5(e)(3) or becomes affiliated with an existing multicandidate committee, whether or not that political committee has certified its status as a multicandidate committee, it automatically attains multicandidate status and must file a FORM 1M (Notification of Multicandidate Status) within 30 days. (11 CFR § 102.2(a)(3))



Regarding item #1 on the attached letter, the following is a response to the notion that our PAC is identified as potentially meeting the criteria of Multicandidate Status under 11 CFR 100.5(e)(3). Note that, although, the count of contributions exceeds 50, our PAC has fewer than 50 contributors. Many of our contributors (employees) use payroll deduction as their contribution method. As such, one contributor could have as many as 24 contributions in one year. Via this communication, I am confirming that our PAC does not have over 50 contributors, and, thus, does not meet all 3 criteria for Multicandidate Status.

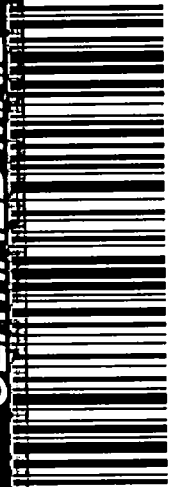
