Dear Mr. Hartsock:

We are in receipt of your letter dated March 5, 2008 concerning our Year End Report for 2007. In your letter, you requested additional information regarding two concerns: in-kind contributions and a description for an itemized disbursement.

With regard to the in-kind contributions, this was simply a reporting error caused by a recent switch to new reporting software. None of the contributions reported during this period were actually in-kind contributions. We have filed an amended report which corrects this error and reports the contributions correctly as monetary contributions. The amended report also includes a clarified description of the disbursement formerly described only as "Consulting: Political" which your letter identified as insufficient. We are confident that the revised description will satisfy your request.

Although it was not a part of your letter, I would like to take this opportunity to inform you that our report covering January 1, 2008 to January 31, 2008 suffered from the same software-generated in-kind reporting error. We have already submitted an amended report for that period as well.
