
Dear Andrew:

Attached are the amended NYNEX Employees' Federal Political Action Committee monthly reports covering the periods November 1994 through August 1996. The reports were amended as follows:

<u>Report for the Period</u>	<u>Reason for Amendment</u>
11/1/94 to 11/30/94	Increased receipts. (As discussed, a deposit was overlooked in the transition from a manual to a mechanized PAC reporting system.)
12/1/94 to 12/31/94	Increased "Cash on Hand at Beginning of Reporting Period" and updated the YTD itemized receipts due to the November 1994 amendment, as discussed.
1995 Monthly Reports	Increased the "Cash on Hand at 1/1/95" and "Cash on Hand at Beginning of the Reporting Period" for each month due to the November 1994 amendment, as discussed.
1996 Monthly Reports through August	Increased the "Cash on Hand at 1/1/96" due to the November 1994 amendment and updated the receipts reported each month. (During an internal review of PAC receipts, it was determined that the Payroll files received by the PAC were inaccurate due to an error in program logic. The Payroll Systems Group corrected the error, retrieved all 1996 payrolls and sent us updated files. We have been assured that the updated files are correct. It should be noted that this problem occurred when NYNEX changed from one payroll system to another in 1996.)


