To Whom it May Concern:

Public Affairs Support Services, Inc. (PASS) provides assistance to Glaxo Wellcome Inc. with the administration of its separate segregated fund, the Glaxo Wellcome Inc. Political Action Committee (the Committee), FEC ID Number C00199703.

An internal review of the Committee's receipts has identified an error: a \$250 check contributed by Timothy J. Myers on November 10, 1997, was incorrectly attributed to James Myers. As a result, the Committee's "Thirtieth Day Report following the Special Election on November 4, 1997, in the State of New York" that was timely filed with the Commission incorrectly itemized the contribution on the Schedule A for Line 11(a)(i) accompanying that Report, and reported an incorrect breakdown of receipts from individuals on the Detailed Summary Page of the Report's Form 3X.

Therefore, enclosed you will find an amendment to the above-mentioned report that consists of the following:

- a replacement page 145 of the Schedule A for Line 11(a)(i), correctly attributing the November 11, 1997 contribution to Timothy J. Myers, and removing the additional itemization of James Myers' November 15th payroll deduction of \$8.23, which would otherwise have been required had the \$250 contribution in fact been made by him;



- a replacement page 589 of the Schedule A for Line 11(a)(i), showing the adjusted total for itemized receipts; and
- a replacement Detailed Summary Page reflecting the adjustment in the entries in Columns A and B for Lines 11(a)(i) and 11(a)(ii).

No other entries on the Detailed Summary Page or the Summary Page are affected by this amendment.
