To whom it may concern, This memo relates to the 48 Hour Notice dated March 10, 2010, filed by The League of Conservation Voters Inc. When filing this notice the committee experienced two problems with the FECFile software. 1. There are two transactions itemized on this report, one for The League of Conservation Voters Inc., the other for Airespring, whose amounts do not appear in Line 7 of the summary page. These transactions, although under \$200, should be part of the total on Line 7. 2. FECFile fails to correctly aggregate the 'Calendar Year-To-Date per Election for Office Sought' field. This field should be the aggregation of every expenditure made supporting or opposing any candidates in the same election. Currently the system aggregates only the total spent per vendor on a specific election. The committee would like to inform the commission that the proper Line 7 total for this report is \$27,002.23.
