To amend your report, you must submit it in an electronic format.

An adequate response must be received at the Commission by February 20, 2002. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule H3 of your report discloses a negative entry in the amount of \$10,525.36 (pertinent portion attached). Please clarify the nature of this transaction:

-Please be advised that Schedule H2 is used for shared federal and non-federal <u>fundraising</u>, exempt, and <u>direct candidate support activity</u>. The ratio for administrative expenses is derived from the Schedule H1 and should not be included on your Schedule H2.

-Line 11(a)(ii) of the Detailed Summary Page discloses \$58,824.00 in uniternized receipts from individuals/persons other than political committees during the reporting period. Please clarify whether this figure includes any receipts from a single source that aggregate greater than \$200 in the calendar year. If this is the case, please amend your report(s) by itemizing the receipts on Schedule A supporting Line 11(a)(i). 2 U.S.C. §434(b)(2)(A) and (3)(A)

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments in an electronic format and must submit an amended report in its entirety, rather than just those portions of the
