
Thank you for your time today on the telephone. Per our conversation, I am writing to explain the reporting errors in the ServiceMaster PAC First Quarter 2000 Report. I also am submitting amended portions of the report.

You noted three errors in your letter to the ServiceMaster PAC:

- 1.) On Schedule B supporting Line 23 we inaccurately reported that a contribution was a primary contribution, but as you noted the Illinois primary took place several days before the contribution date. The contribution date was correct, but we inaccurately checked the "primary" box. The amended Schedule B corrects this error.
- 2.) The cover sheet of the First Quarter Report inaccurately indicated that it covered the full quarter. While the report itself correctly contained only activity subsequent to the pre-primary filing, we mistakenly indicated that the First Quarter Report covered January 1, 2000 - March 31, 2000. This is corrected on the amended cover page.
- 3.) Our identification number contained a typographical error. This is corrected on the amended cover page.
