- Ten (10) of the listed contributors had their excessive contributions properly and timely reattributed to their spouse;
- Fifteen (15) of the listed contributors had their excessive contributions properly and timely either refunded or charged back to the contributor's credit card;
- Three (3) of the listed contributors had their excessive contributions properly and timely redesignated to the Committee's General Election Account;
- Two (2) of the listed contributors had their excessive contributions properly and timely returned to a JFC for proper reallocation;
