

The long strings of numbers and letters above are "receiving addresses" associated with a bitcoin wallet. In the bitcoin payment system, receiving addresses allow for the deposit of funds denominated in bitcoin. The balances and transaction histories of these addresses are publicly recorded in the bitcoin blockchain and can be viewed at any time using a service such as [blockexplorer.com](http://blockexplorer.com).

It is our intent to collect funds denominated in bitcoin at the ten receiving addresses above. We are submitting this list of addresses to satisfy line 9 of FEC form 1. If additional receiving addresses are needed in the future, an amended statement of organization will be filed in advance of receiving funds at the additional addresses.


