On October 23, 2014, Pandora PAC sent a \$2,400 contribution check to Jerry's PAC. This check was returned (enveloped unopened and check uncashed) to Pandora, presumably due to an error in the address or postage. The returned check was mistakenly given to Pandora's Accounts Receivable Collections department and deposited into Pandora's master operating bank account with JPMorgan Chase. The deposit went unreconciled until March 2016 when it was brought to the attention of Pandora PAC and, on March 15, 2016, was then transferred from Pandora's master operating account to Pandora's PAC account.
