This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule B supporting Line 23 of your report discloses a contribution to the Connecticut Coordinated Campaign Federal Account. However, there does not appear to be a committee registered with the Commission under this name. Please amend your report to clarify the name of this committee, so that the contribution can be properly attributed.

-Your report disclosed a category of financial activity that has been reflected on the wrong line of the Detailed Summary Page. In-Kind Contributions to federal candidates should be properly disclosed on a separate Schedule B, supporting Line 23 of the Detailed Summary Page. Please refer to the instructions contained on the forms to determine the proper categorization when preparing your next filing.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
