1. Your report discloses Offsets to Operating Expenditures on Line 20(a) of the Detailed Summary Page without corresponding expenditures (see attached). Please be advised that if there are not corresponding expenditures for these entries, it may constitute an excessive or prohibited contribution. Please amend your report or provide an explanation for this apparent discrepancy. (11 CFR § 104.3(a)(4)(v))
2. Schedule B-P supporting Line 28(a) of your report discloses refunds to individuals. It appears that your committee has refunded an amount greater than the original contributions for the attached contributors. Please clarify these refunds and amend your report(s) as necessary. (52 U.S.C. § 30104(b) (formerly 2 U.S.C. § 434(b)) and 11 CFR § 104.3(a))


