Dear Ms. Manzano:

In reply to your letter of June 26, 1998, concerning the matter of the \$30,000 loan made to Lacy for Assembly, you will note on the attached 2nd Quarter Report that the loan was repaid on 4/16/98. Let me assure you that the repayment was made entirely with permissible funds. It is a matter of record that the Lacy for Assembly campaign received no corporate contributions until well after the date of repayment and that all contributions through the date of repayment were raised from permissible sources.

As to the second point in your letter concerning computer produced formats. In actuality, the only computer produced form we use is the Schedule A. We were under the impression that this format had been approved many years ago and were not aware we needed to submit a request for approval. This week we have submitted a request under separate cover for approval of our Schedule A. As to the other schedules we are not using computer produced forms, but we are photocopying FEC forms and using a word processor to fill in the variables. If this procedure also requires a separate approval, please let me know and I will follow through with a request.

I hope this addresses the concerns outlined in your letter. If you have further questions please let me know and I will do my best to answer them.
