The Santa Clara Republican Party tracks employee time spent on federal election activity and federal campaigns on a monthly basis per Federal Election Commission regulation. Payroll on schedule H4 was for administrative employees who do not spend more than 25% of their time on Federal Election Activity.

Regarding voter registration on 2/6/06: Amended March Monthly Report (2/1/06 to 2/28/06)

We have amended our report to recode this as 100% FEA.
