By now you are aware that I will not run for re-election in 1994. My reasons are many and I have enclosed a summary of my comments regarding my decision not to be a candidate.

Most importantly, with a sense of special appreciation I thank you for your loyalty and support on behalf of my Senate service over these many years. On a personal note, your friendship and getting to know you as well as citizens around Arizona and our country is my special reward. You have helped to shape that reward.

The enclosed check represents the pro-rata portion of your campaign contribution after all campaign bills were deducted and closing costs were estimated.
