Dear Ms. Hurd:

This responds to your letters dated July 9, 1997, regarding Safety-Kleen Corp. PAC's 1996 May, June and September reports.

The contribution made to Dennis Hastert on 4/29/96 was intended for his 1996 general election. The contribution was not designated for a particular election and was delivered to his committee during the general election period. It was mistakenly reported as a contribution for the primary.

The total listed on Line 11(a)(ii), Column B of the Detailed Summary Page was typed incorrectly. It should have appeared as \$5,282.76. The total for Line 11(d) is correct, as are the amounts for Line 11(a)(ii) on subsequent reports.

The total for Line 11(a)(i) on the Detailed Summary Page correctly disclosed \$751.92 in Itemized Contributions from Individuals. The entry for Scott Fore on Schedule A was not completely typed and should disclose two \$30 contributions for the period. These contributions were correctly added to the subtotals and total for the period.


