This amended report is in response to the 2/27/2022 request for additional information received by the committee. Disbursement purposes for transactions on Line 21(b) have been updated to include a description.

The National Football League (NFL) donated 6 hours of professional staff time (valued at approximately \$1,517.64) this reporting period to ensure compliance with the Federal Election Campaign Act. All of the services to ensure compliance with the Federal Election Campaign Act, that the National Football League donated to the PAC for the period of July 1, 2021, through December 31, 2021, took place between July 1, 2021 through December 31, 2021. The National Football League (NFL) provided 11.25 hours of professional staff time (valued at approximately \$2,087.87) with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period July 1, 2021, through December 31, 2021 took place between July 1, 2021, through December 31, 2021.

Gridiron PAC reported a \$11,722.48 in-kind contribution from the NFL on 6/30/2021. Due to an \$8,009.81 remaining balance in the drawdown account from the prior in-kind services prepayments made on January 31, 2020, the net overall in-kind contribution for calendar year 2021 was \$3,712.67 as of June 30, 2021. Gridiron PAC made a subsequent disbursement to the NFL on July 28, 2021 in the amount of \$13,712.67 to replenish the previously depleted drawdown balance. After the previously reported net in-kind contribution of \$3,712.67 was applied along with the \$2,087.87 of in-kinds in the current reporting period, the available drawdown balance as of 12/31/2021 is \$7,912.13.
