Re: Amendments to FEC3X

In response to your letter dated March 16, 2005, the following is the amended report for Montana Action Committee for Rural Electrification. The areas of change are outlined as follows:

Page 2 – Summary Page – changes to cash paid out reflected on new page 2, as well as debt recorded.

Schedule A – Itemized receipts – Page 10 is amended for Proceeds for Auction Items Sold. There is now a \$0 balance for that line item.
