Dear Mr. Foley:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please be advised that a national party committee may make coordinated expenditures for the General Election only. 2 U.S.C. (441a(d)) Your report includes a Schedule F (pertinent portions attached) that fails to disclose clearly identified federal candidates, and the expenditures do not appear to have been made for the General Election.

The Act also prohibits a National Senatorial Committee of a political party from making a contribution to a candidate for office of Senator in excess of \$17,500 in an election year. (2 U.S.C. 441a(h)) If you have made an excessive in-kind contribution, you should notify the recipient and request a refund of the amount in excess of \$17,500. Any refund should appear on Schedule A supporting line 16 of your next report.

If the expenditures in question have been incorrectly disclosed, you should amend your report with clarifying information.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this
