This responds to your letters dated July 26 and July 27, 2005, concerning the above referenced reports.


When preparing the amendment to the September Monthly Report dated June 16, 2005, we erroneously included the original schedules E, rather than the amended schedules E which were included in our amended September Monthly dated November 29, 2004. We have amended the September Monthly with the correct schedules E. The payments to Peter D. Hart Research Associates, Inc. and Global Strategy Group, Inc. were reclassified in our November 29, 2004 amended September Monthly Report from Schedule E, Line 24 to Schedule B, Line 21b.

With the filing of this amended September Monthly Report, the schedules E calendar year-to-date per election will now be correct as reported on the Committee's amended October Monthly dated 6/29/05.
