If in fact this can't be accommodated the campaign will have to acquire the funds which aren't in the campaign account to cover this expense which is the responsibility of the campaign

Being a third-party candidate means that you are a one man campaign and essentially all the important duties fell on my shoulders and my ability to execute them were compromised for several months as I recuperated.

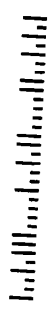
