Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

- -Your calculations for Line 6(d), Column B appear to be incorrect. FEC calculations disclose this amount(s) to be \$44,861.53. Please provide the corrected total(s) on the Summary Page.
- -Your calculations for Lines 30 and 31, and Column A appear to be incorrect. FEC calculations disclose these amounts to be \$1,715 and \$1,715, respectively. Please provide the corrected totals on the Detailed Summary Page.
- -Please provide the total(s) for Line 21(c), Column B, of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.
- -The totals listed on Lines 11(a)(ii), 11(a)(iii), 11(d), 19, 23, 30 and 31, Column B of the Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any

subsequent reports that may be affected by this correction.

-Your committee has filed a report that contains financial activity already disclosed on another report. Overlapping coverage dates create difficulties in accounting for cash flow from one report to another. Please amend this report by including only the financial transactions that occurred between 10/19/00 and 11/27/00. 2 U.S.C. §434(b)

-Line 23 of the Detailed Summary Page of your report discloses a total of \$1,100 in contributions to federal candidates/committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$400. Please amend your report to clarify the discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
