Dear Mr. Hartsock:

This letter is subsequent to my letter of July 20, 2005, regarding a contribution made to Bush-Cheney '04, Inc. by Harleysville Insurance Political Action Committee-Federal (“HIPAC-Fed”). As stated in my previous letter to you, HIPAC-Fed requested a refund in the amount of \$3,000.00 from Bush-Cheney '04, Inc. on July 19, 2005.

Upon receipt of my letter by Bush-Cheney '04, Inc, I received a telephone call from Timothy Beall, of Bush Cheney '04, Treasury and Compliance. According to Mr. Beall, HIPAC-Fed is not required to request a refund because its contribution was issued and post-marked before September 1, 2004 (the date public funds were accepted by the campaign committee), and was properly received and reported by the Bush-Cheney '04 Inc. Primary Committee.

Apparently HIPAC-Fed inadvertently reported the contribution as made to the Bush-Cheney '04 General Committee rather than the Bush Cheney '04 Primary Committee. In actual fact, the contribution was properly made by HIPAC-Fed to and received by the Bush-Cheney '04 Primary Committee.

As such and if you are in agreement, we will electronically amend HIPAC-Fed's 2004 October Quarterly Report (07/01/04 to 09/30/04) to reflect the correct contribution and campaign information. In doing so, we will change the contribution box checked from “General” to “Primary.” We will also change the name to Bush-Cheney '04 (Primary) Inc. as the proper recipient of the contribution. Finally, we will inform Mr. Beall that HIPAC-Fed will not require a refund of the said HIPAC-Fed contribution. Enclosed you will find copies of the post-marked envelope and the check, which were forwarded to my attention by Mr. Beall.




