Dear Ms. Reynolds:

I am in receipt of your letters dated February 12 and 14, 1997 regarding the National Restaurant Association Political Action Committee's (NRA-PAC) 1996 August, October, and 30 Day Post-General Reports. Your letters noted that contributions to three different candidates appear to exceed the limits set forth in 2 U.S.C. 441a(a). The NRA-PAC has researched each of these contributions in response to your inquiry. As a result, we have amended each of the reports referenced above to conform with our documentation.

Specifically, with respect to the July 16, 1996 contribution to the Friends of Jim Inhofe, the NRA-PAC was asked by the Inhofe Committee to redesignate the contribution for the general election and did so on July 29, 1996. Thus, the contribution should have been reported as a general election contribution. The August Report has been amended to reflect this change.

With respect to the September 25, 1996 contribution to the Al Saivi for Schate Committee, while it was the NRA-PAC's intent to make a primary debt contribution, the documentation accompanying the check did not inform the Committee of such. Thus, the NRA-PAC has asked for a refund. A copy of that request is enclosed.

Finally, with respect to the Robert Wexler for Congress contributions, we have amended the reports to reflect two changes. First, the September 24, 1996 contribution has now been identified as a primary runoff contribution as it had been identified on the contribution itself. Furthermore, we have clarified the contribution dated November 6, 1996 to identify it as a general debt contribution.
