2. Report type and Period covered.

We list this information in section 4 and in section 5 of the form.

3. Type of communication, Class of communication, Name of the candidate, Date of the expenditure, and the Cost of each expenditure.


This information is shown under the heading Summary of Communication Costs. Using the first page of the October Quarterly Report as an example, the information is reported as follows:

There is a request to amend our report to show the office sought for each candidate. This information is already provided on Form 7 beside the candidate's name. Using the above-mentioned report as an example, to the right of Melissa Hart's name is PA - 4, which shows that the candidate is running for House district 4 in the state of Pennsylvania. To the right of John Tanner's name is TN - 8, which shows that the candidate is running for House district 8 in the state of Tennessee. To the right of Bob Ney's name is OH - 18, which shows that the candidate is running for House district 18 in the state of Ohio. To the right of Phill Kline's name is KS - 3, which shows that the candidate is running for House district 3 in the state of Kansas. A copy of this example page is enclosed.
