The National Football League ('NFL') provided 1.0 hours of professional staff time (valued at approximately \$184.19) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. The National Football League also provided 26.5 hours of administrative staff time (valued at approximately \$583.00) in this reporting period with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period of July 1, 2018 through July 31, 2018 took place on July 2, 2018 through July 31, 2018. On July 31, 2018, Gridiron-PAC made a \$3,500 in-kind services prepayment to the NFL. The total funds retained by the NFL on prior prepayments, as of June 30, 2018, was \$1,561.80. In this reporting period, the prepayments are used to offset \$767.19. The total funds retained by NFL as of July 31, 2018 is \$4,294.61.
