Dear Mr. McAllister:

3<sup>rd</sup> quarter of 2009 we received a \$5,000 donation for our PAC Fund, which we then disbursed to Congressman Carney. We reported this transaction on our local and state reports for 2009, not knowing we had to also file a federal report. This was our first large donation to a federal candidate. Attached is a Form 3X for 2009 which explains the refund reported on our 1<sup>st</sup> quarter 2010 report.

In the 1<sup>st</sup> quarter of 2010 Congressman Carney's office returned \$4,100 of the said donation as he did not have a FEC Identification # for us. We had to then apply for the FEC#. We received this number in the first quarter so we then returned the \$4,100 donation back to Congressman Carney with our ID# on the check. There is no change in the 1<sup>st</sup> quarter 2010 FEC FORM 3X.

1. Please provide the total(s) for Line 6(c), Column B of the Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.
2. Schedule A supporting Line 16 discloses a refund of a contribution made to "CARNEY FOR CONGRESS" on 3/29/10. However, it appears that a contribution to this candidate was not made until 3/31/10. Please amend your report to clarify this apparent discrepancy.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. If you should have any
