
Dear Ms. Benitz:

This is in response to your request for information in your July 11, 2008 letter to the Motion Picture Association of America Political Action Committee, identification number C10039519. Your letter requests a written response. Although I called the commission and spoke with Chris and he stated this issue was resolvable in an electronic filing, I thought I should respond in writing as well so you would where this issue stands.

I contacted the campaign committee, to which the contribution in question involves, Friends of Max Baucus. It appears the reporting error is only on the end of the MPAAPAC. Friends of Max Baucus reported the amount of \$2500, made on 5/29/07, correctly to the primary election and not the general election. I made the error of designating the contribution incorrectly to the general election at that time.

Chris said I could fix the report containing the designation error and explain the error and correction in a memo. I made the redesignation correction in the June 2007 report and I added an electronic miscellaneous filing to explain the error. With this correction, the contributions made by the MPAAPAC to Friends of Max Baucus should now be within the limits allowed by Federal Law. I hope my actions are a satisfactory corrective solution to this error. If not please contact me at (202) 413-4613 or (202) 378-9125 at your convenience.
