This letter is in response to your letter dated April 21, 2011 requesting additional information in connection with the 30 Day Post-General Report (10/14/10 – 11/22/10) filed by Friends of Barbara Boxer (“Committee”).

The following contributions were disclosed on 48-Hour reports, but not on the Committee’s Post-General Report:

These contributions represent allocations for transfers from joint fundraising committees. Because these contributions would have resulted in excessive contributions to Friends of Barbara Boxer, they were ultimately reallocated to the other joint fundraising committee participants before the Committee filed its Post-General Report.

The following credit card contributions were properly disclosed on 48-Hour reports and were disclosed by the committee on its Post-General report. However, the Committee inadvertently used an incorrect date received on the FEC Form 3. The Committee inadvertently disclosed on the FEC Form 3 the date the credit card charges were authorized, rather than the date the contributions settled in the campaign account, which is the Committee's standard practice and the date that was used on the 48-Hour reports. The Committee has amended the FEC Form 3 for the following contributions to conform the received date with the date disclosed on the Committee's 48-Hour reports:

The following contributions were inadvertently not included on a 48-Hour report; however, the Committee has since filed a 48-Hour report disclosing these contributions.


