The Ted Cruz for Senate Committee (hereinafter "Committee"), FEC ID# C00492785, is in receipt of your Request for Additional Information (RAFI) dated May 15, 2013. The Committee's response follows.

The Committee has reviewed the transactions identified in the RAFI for excess contribution limits. For each of the donors that are not resolved as a matter of course per the regulations relative to reattributions/redesignations on subsequent reports, the Committee will amend its reports accordingly to show the proper outcome of each transaction.

Contributions disclosed on reports that were marked as primary or runoff contributions but reported after the primary and runoff elections were accepted to pay toward respective debt. Any excess funds accepted toward debt retirement have been refunded to the original donors.


For the contribution refunds identified in the RAFI, the original contributions and/or reattributions/redesignations were disclosed on the following reports:


