Dear Ms. Daughtrey:

This letter is in response to your letter dated May 1, 2009 regarding the NRA Political Victory Fund s amended 12 Day Pre-General Report (10/01/08 10/15/08) notifying us of a failure to file 48 hour reports.

In your letter, there was a spreadsheet that showed entries pulled from Schedule E. These disbursements were prepayments that were fully itemized during the reporting period that they were paid. Most of the independent expenditures listed were disseminated in a later reporting period. Attached is that spreadsheet with two additional columns listing the 24 / 48 Hour Report disclosure date and amount.

The Radio Ad allocated to Senator Elizabeth Dole in the amount of \$35,000.00 on 10/09/2008, was disseminated twelve days later with the addition of another candidate. The 48 Hour Report filed 10/21/2008 reflects the correct allocation of \$17,500.00 for Dole and \$17,500 for Kay Hagan. An amended 12 Day Pre-General Report will be filed to add the additional candidate to the television air time purchase.
