### II. Activities to be Undertaken

The two non-profit organizations listed above, acting as a Host Committee pursuant to 11 C.F.R. §9008.50(b), will:

- (a) Defray the expenses incurred in the promotion of the Charlotte area for the 2012 Democratic National Convention (the "Convention");
- (b) Welcome Convention attendees to the Charlotte area by sponsoring information booths, receptions, tours and other similar events and facilities;
- (c) Defray expenses incurred in facilitating commerce, such as providing Convention attendees with guides to the Charlotte area and distributing samples and promotional materials;
- (d) Defray administrative expenses incurred by the Host Committee organizations themselves, such as salaries, rent, travel and insurance;
- (e) Provide and defray the costs of a comprehensive insurance program for the Convention;
- (f) Provide the 2012 Democratic National Convention Committee ("DNCC") with the use of the Time Warner Cable Arena for the Convention proceedings, and use of the Charlotte Convention Center for certain other purposes; and to provide construction and convention related services for and in the Time Warner Cable Arena including such items as are set forth in 11 C.F.R. §9008.52(b)(5);
- (g) To provide other Convention related facilities and services for the use of the DNCC including office space, facilities, equipment and supplies; communications devices and services; technology including hardware and software components of local and wide area computer networks;
- (h) To defray the costs of local transportation services, including the provision of buses and automobiles and use by Convention attendees of public transportation systems; and
- (i) To provide other similar Convention-related facilities and services.
