I was born in Pacifica, California but I moved to New Jersey with my mother. After graduating Rahway Flight School in 1999, I attended Norwich University in Vermont. There, I spent my days studying, snowboarding and became a momber of Mountain Cold Weather Rescue Team.

After dating for almost two years, we were married on September 20th, 2008. We have since had two daughters, London Christina and Madison Owen Castle. Everyday I strive to set the best possible example for my daughters and be the constructive male role model that I lacked growing up.

Thinking of my children and their future, I have gown increasingly troubled by the state of our nation and the leadership of our politiciaos. I first began to feel this frustration while serving in Iraq when I witnessed with the profound divide between those Washington and the realities in the field. Washington has only grown more fractured and disconnected since then.

After September 11th. I felt compelled to serve because I knew that the threat facing our nation was grave and in the Marine Corps I could make the greatest impact. I feel that same conviction today. The challenges that America faces in 2012 are as serious as those we faced a decade ago. Millions of our friends and neighbors are out of work. Our education system is floundering and leaving many students unprepared. 
