The purpose of this amendment is to 1) correct a typo in the amounts of the North Star Multimedia Schedule B, (Previously listed as \$13,750, when it should have been \$13,500) and the Schedule E dissemination via North Star, (Previously listed as \$18,500, when it should have been \$18,750). This typo resulted in the incorrect amounts being reported on the F24 for this disbursement/dissemination. The F24 on 4/25 will be amended as well, to reflect this correction. 2) The second purpose of this amendment is to correct a clerical error regarding PayPal donations. The Paypal donors appear to have been uploaded twice/duplicated. The duplicates were all small donation amounts, and did not aggregate into Schedule A's. We have deduplicated the donation data, and are amending 2021-MY through 2022-M5 to correct the opening and closing balances affected by this change. We are also using these amendments as an opportunity to update the public record for the employer and occupations that we've obtained from the donors with previously missing or unacceptable values.
