The National Football League (NFL) donated 1 hour of professional staff time (valued at approximately \$223.78) this reporting period to ensure compliance with the Federal Election Campaign Act. All of the services to ensure compliance with the Federal Election Campaign Act, that the National Football League donated to the PAC for the period of January 1, 2023, through June 30, 2023, took place between January 1, 2023, through June 30, 2023. The National Football League (NFL) provided 1.95 hours of professional staff time (valued at approximately \$436.37) with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period January 1, 2023, through June 30, 2023 took place between January 1, 2023, through June 30, 2023.

As of June 30, 2023 the current balance of the drawdown account for prepayments of in-kind services is \$6,360.92. During the course of a recent audit, it was discovered that the running cash on hand reported on the public record was lower than the running cash balance in the PAC Bank Account. This report includes a balance adjustment on line 17 in the amount of \$3,953.79 to account for this variance. It is believed this variance is a result of over-reporting credit card transaction fees over the years and crosses multiple election cycles. As a precautionary measure and because we were not able to determine the exact source of the extra funds, a payment to the US Department of the Treasury was made on 02/03/2023 in the amount of \$3,953.79 to disgorge these funds.
