Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following $\underline{1}$ item(s):

- Schedule B of your report (see attached) discloses an apparent excessive contribution(s) made to a federal candidate(s). The Act prohibits a multi candidate committee from making a contribution to a candidate for federal office in excess of \$5,000 per election. (52 U.S.C. \$30116(a))

The Commission notes the refund of the excessive contribution(s) on your April Quarterly Report (1/1/23 - 3/31/23). Although the Commission may take further legal action concerning the excessive contribution(s), your prompt action in obtaining a refund or redesignating the contribution(s) will be taken into consideration. (11 CFR §103.3(b)(1) and (3))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
