Dear Mr. Whyrick,

I am in receipt of you Request For Additional Information dated September 16, 2008, regarding American Future Fund's Form 9 filed August 29, 2008. As you have noted, this filing was received by the FEC without certain supporting schedules. This omission was either the result of inadvertent error on the part of American Future Fund, or a technical malfunction involving one of the two fax machines involved in the transmission. We have been unable to determine which, if either, fax machine was at fault.

Immediately upon becoming aware that the FEC had posted an incomplete report on its website, we contacted Public Records, which confirmed that the FEC had only received the one page that was posted on the website. American Future Fund then re-faxed the complete report to the FEC on September 4 (see http://images.nictusa.com/cgi-bin/fecimg/?_28039824021+0 and attached).

As noted above, we believe this omission was either the result of inadvertent error on the part of American Future Fund, or a technical malfunction involving one of the two fax machines involved in the transmission. Upon learning of the error, American Future Fund took immediate steps to correct the filing.

I would like to note that on two instances prior to August 29, American Future Fund filed complete reports with the FEC. I hope this demonstrates to your satisfaction that this was a one-time occurrence. Additionally, American Future Fund has since implemented internal policies to ensure that the FEC receives all pages of its filed reports.

- 1. On Line 11 of your filing, you have failed to disclose the person or persons sharing or exercising control of the making of the disbursement/obligation for the electioneering communication. You must provide the name, address, employer, and occupation of each person sharing or exercising control. (11 CFR § 104.20(c)(2)) Please amend your filing to include the missing information.
- 2. Line 10 of the FEC Form 9 discloses \$507,661 in total disbursements/obligations. However, you have failed to file a Schedule 9-B supporting this amount. Please amend your filing to correct this discrepancy. (11 CFR § 104.20(b))

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action

against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
