The third quarter report includes the \$30,725.00 deposit on 9/11/06. The deposit included \$4,025.00 in individual contributions of which \$4,000.00 is itemized. Contributions attributed to individuals should not be included in their 2006 federal contribution limits. The report also includes \$26,700.00 in PAC contributions that are itemized on the report. The Pac's are not registered with the Federal Election Commission.
