This letter is prompted by the Commission's preliminary review of the report referenced above. 1. Your report contains financial activity disclosed on a previous report. Overlapping coverage dates create difficulties in tracking the committee's cash flow. Please amend this report to include only the financial transactions that occurred between 11/29/2016 and 12/31/2016. (52 U.S.C. § 30104(b) (formerly 2 U.S.C. § 434(b)) and 11 CFR § 104.3)
2. The beginning cash balance of this report does not equal the ending balance of your Amended 30 Day Post General Report. Please correct this discrepancy and amend all subsequent reports that may be affected by the correction. (52 U.S.C. § 30104(b)(1) (formerly 2 U.S.C. § 434(b)(1)) and 11 CFR § 104.3(a)(1))
3. Schedule D of your report itemizes debt(s) owed to "Largent, Charles," "Largent, Regina L" and "Zingone, Edward M" with an outstanding beginning balance.
