
-Your calculations for Line 31, Column A appear to be incorrect. FEC calculations disclose this amount to be \$9,542.05. Please provide the corrected total on the Detailed Summary Page.

-Please provide a Schedule B to support the entry reported on Line 22 of the Detailed Summary Page. Each transfer-out to an affiliated committee must be itemized on Schedule B regardless of the amount transferred. 2 U.S.C. §434(b)(6)(B)(i)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this
