Dear Mr. Decker:

As per our phone conversation on July 19, 2005, we are attaching the following amended FEC reports for the Women Under Forty Political Action Committee (WUFPAC):

As we discussed, Jessica Clark has just assumed the position of Treasurer of WUFPAC and, while reviewing the committee's past reports, she realized that the prior treasurers had made two reporting errors.

The first error was that the treasurer, in the October 15th Quarterly Report 2004, characterized a debt owed in respect of an unpaid invoice as a loan and completed Schedules C and A (line 13) instead of Schedule D. This error was carried through successive reports. The attached amended reports reflect the correct characterization of the amount owed as a debt, not a loan. As a result, the amount of the debt has been subtracted from the

The second error was that the previous treasurers had failed to record certain bank service fees and PayPal service fees as disbursements in our FEC filings. To remedy this mistake, following your recommendation made during our telephone conversation on July 19, 2005, we have amended all reports dating back to the Year End Report 2002.
